~Once operational, refinery to produce 8.7 lakh tonnes of petrol and 23.71 lakh tonnes of diesel per year~

New Delhi, April 28, 2010: Punj Lloyd Group, the global engineering, procurement and construction (EPC) conglomerate, today announced that it has been awarded an order for Cuddalore Refinery Project of Nagarjuna Oil Corporation Ltd in Tamil Nadu.
