Crude Oil Storage Tanks, designed and constructed by Punj Lloyd, enter 'Malaysia Book of Records'

15 October 2018: Diversified EPC conglomerate Punj Lloyd today announced that the Crude Oil Storage Tanks, designed and constructed by it for Petronas - Malaysia's national energy company, have been listed in the Malaysia Book of Records.

Punj Lloyd was awarded the RAPID Tank Farm order, an Rs 3,515 crore (USD581 million) project from PRPC Refinery and Cracker Sdn. Bhd.; a subsidiary under the Petroleum Nasional Berhad (PETRONAS) group.

The RAPID Tank Farm entailed construction of a diversity of tanks including storage tanks, LPG tanks, mounded bullets, Light Cracked Naphtha storage, transfer pumps and additive packages.
