Notes to the financial statements For the financial year ended 31 March 2015

#### 1. Corporate information

Sembawang (Tianjin) Construction Engineering Co., Ltd. (the 'Company') is a joint venture established in Tianjin in the People's Republic of China (PRC) by Tianjin International Investment Engineering Corporation and SembCorp Engineers and Constructors Pte., Ltd., ('SembCorp E&C') registered in Singapore. On 9 April 1995, the Company obtained an approval certificate of foreign investment, which is 'Shang Wai Zi Jin Wai Zi Zi [1995] No. 0120 from Tianjin Municipal People's Government. On 13 March 1995, a business license 'No. 007820 Qi He Jin Zong Fu Zi' issued by Tianjin City Administration for Industry and Commerce. The registered capital is USD 3,000,000.00.

In 1998, the Board of Directors approved of the former Chinese investor - Tianjin International Investment Engineering Corporation, to transfer all its 30 per cent share capital to Tianjin Construction Engineering Group. The Company had revised the relevant registration accordingly. On 12 March 2002, Tianjin Construction Engineering Group (Holding) Co., Ltd., and revised the relevant registration accordingly.

On 17 January 2007, the Board of Directors approved the resolution for company name change. The original name of 'SembCorp (Tianjin) Construction Engineering Co., Ltd.' was changed to 'Sembawang (Tianjin) Construction Engineering Co., Ltd.'. The new foreign investor - 'SembCorp E&C', had changed its name into 'Sembawang Engineers and Constructors Pte, Ltd.'.

According to articles of incorporation, the Company's operation period is 20 years and its main businesses are contract management, manufacturing and selling of building components, and consultation service of construction design. The company commenced operating on 13 March 1995.
